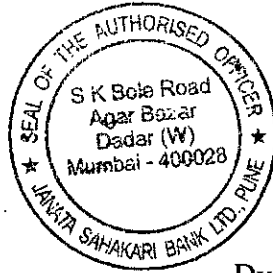

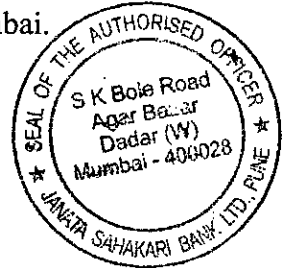

- 1) The Property will be sold on "As is Where is Basis."
